I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my use of Penobscot Adventures Inc. recreational equipment and my participation in whitewater rafting, rock climbing, kayaking, paintball, hiking, biking etc, activities: (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and or total paralysis, death or other ailments that could cause serious disability: © these risks and dangers may be caused by the negligence of the owners, employees, officers, or agents of Penobscot Adventures Inc.; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes.
