Scholarship applications are due on May 15th. Notification will be shortly after this date. It is possible that we may still have scholarships available after that date, on a case by case basis – please check with us.

Each summer, requests far exceed the amount of funds we have available for students – and this is allocated based on demonstrated financial need and the enrollment needs of our program. Unfortunately we are not able to offer financial assistance to all applicants, and rarely are able to offer a full scholarship.

Be aware that the only way to hold a space on an expedition is to submit a \$600 deposit, which, if it is accompanied by a complete scholarship application (as per above), can be fully refundable if you withdraw your application, in writing by June 1st.

Please be assured that this information will be kept confidential.
